Greetings and good wishes!

Vide Government Order No. 15 - JK (DMRRR) dated 13 February and Order No. 72 - JK (Edu) of 2022 dated 16 February 2022 physical attendance of pupils **shall resume in a staggered manner**. Classes shall be conducted in compliance with SOP for protection against COVID – 19.

1. The resumption of classes will be as per following dates:

• Classes 6th - 10th

2nd March, 2022

• Classes 1st - 5th

7th March, 2022

• Classes Nursery to UKG

10th March, 2022

- 2. All pupils in the age of 15 years (and above) are required to carry a copy of proof of vaccination against COVID 19. This shall be submitted to the Form Teacher for verification and record. **NO PUPIL OF AGE 15 YEARS (AND ABOVE) SHALL BE PERMITTED TO ATTEND CLASSES WITHOUT PROOF OF VACCINATION.**
- 3. All pupils attending physical classes must submit a hard copy of the **PARENT CONSENT FORM** that is attached with this notice to the concerned Form Teacher on the first working day.
- 4. Student will carry a *notebook*, *charts*, *colours* (of all kinds) along with them. No books need to be carried.
- 5. In the interest of health safety, it is compulsory for pupils to;
 - Wear a face mask at all times.
 - Carry a limited amount (100ml) of hand sanitizer for individual use
 - Water Bottles for individual use.
 - Pupils are requested to carry a wholesome lunch. NO junk food will be permitted.
 - Students suffering from cold, cough and fever are requested to stay at home and send online leave application to form teacher.
- 6. Pupils may come in casual wear but in a **PRESENTABLE MANNER**.
- 7. No transport facility would be provided to students in 1st week of March, 2022.
